1. Community (Social and economic) development and Community based organization:

1.1 Community development can be defined as "a process where community members come together to take collective action and generate solutions to common problems."It is a broad concept, applied to improve various aspects of communities, typically aiming to build stronger and more resilient local communities.

The Role of Community in Economic Development:

Community is considered the third pillar of any economic system in addition to the market and the state. The market is an organization coordinating competition among people seeking profits by impersonal means of prices, and the state intervenes in matters of resource allocations through the use of coercive power. In contrast, the community organizes collective actions based on mutual trust within a small group characterized by intensive interactions. The community's role in conserving and improving common-property resources is well known.

Community based organisation (CBO):

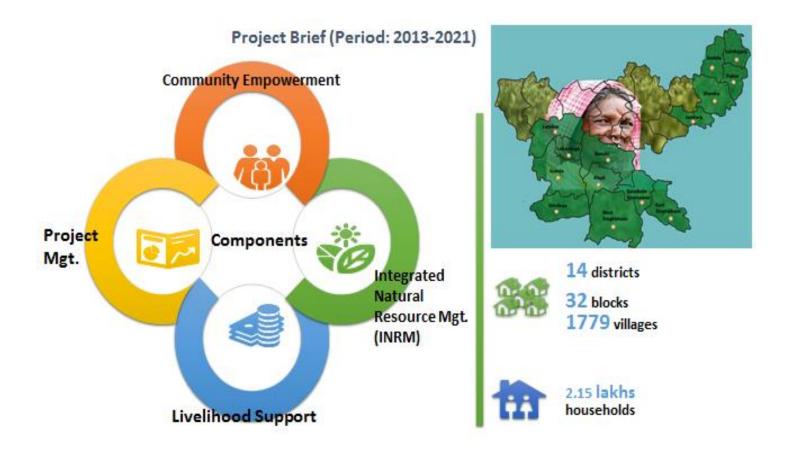
Community-based organizations, or CBOs, are local non-profit groups that work to generate improvements within a community on the local level. They are basically the community development process in the form of a formal organization. They are usually locally formed, locally staffed (if required), and their actions are specific to the location they operate in. Most CBOs are mainly volunteer organizations, with few paid positions as most of their funding is delegated towards completing the group's objectives. Their local status also means that they may be limited in what resources they have access to, depending on the geographical location of the CBO and the community it serves.

Since they are so localized, a CBO is only going to tackle issues (socio-economic) within the community they operate in. These groups are free to look at issues that exist outside of their community that are affecting the community itself, but they will just look at how those issues impact things within that particular space. In some instances, a CBO may collaborate on an issue outside of its community with another CBO. This usually happens when there is some overlap in regards to their areas of interest, such as shared geographic boundaries between the two communities.

2. JTDS, JTELP and community based organizations:

The overarching goal of JTDS is to improve the living conditions of tribal people in general and Particularly Vulnerable Tribal Groups (PVTGs) in particular. This is sought to be achieved by organizing and enabling the communities to adopt sustainable and productive natural resource management regimes, adopt market-oriented production systems and learn the skills and gain the experience of planning and implementing development plans relevant to their villages.

The Jharkhand Tribal Empowerment and Livelihood Project (JTELP) focus on two major theme; Empowerment and livelihood and is being implemented in the 14 Tribal Sub Plan (TSP) Districts of Jharkhand spread across 32 blocks, 169 Panchayats and 1779 villages. Most of these districts are also the part of aspirational districts categorised by the Government of India.

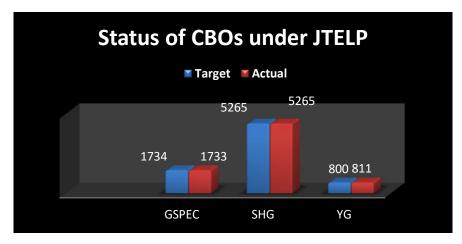


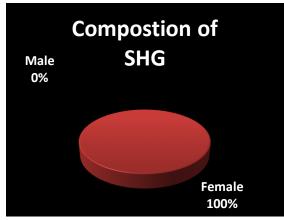
Under the mandate of the project emphasis is given on the formation, nurturing and sustaining community based organization. Under JTELP mainly three types of CBOs have been formed, nurtured and focused for sustenance of project.

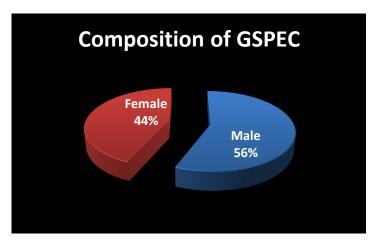
- A. Gram Sabha Project Execution Committee (GSPEC)
- B. Women led Self Help Group (SHG)
- C. Youth Group (YG)

In the command area of the project (JTELP), continuous efforts are being made to strengthen the community leadership and to provide them support in such a way that rejuvenates the tribal community to overcome backwardness. To support the community institutions like SHG (Self Help Group), YG (Youth Group) and GSPEC (Gram Sabha Project Execution Committee) standard guidelines has been prepared in consultation with all stakeholder and the same is being implemented. VDF(Village development fund) for GSPEC and seed capital for SHG and YG has also been conceptualized and rolled out keeping the future plan of action in mind.

The engagement plan with CBO/individual members is a based on four different level where the community is in the center stage.

As per the above data all total 1733 GSPEC have been formed, consisting of 18579 members. Out of 1733 GSPEC 244 GSPEC are PVTG GSPEC and 1489 GSPEC are Schedule Tribe GSPEC.

As per the Project Guideline each GSPEC will be provided Village Development Fund for the utilization for necessary situation/need for the community. The fund may be a like coping mechanism for the whole society of operational villages. Under the project a Village Development Fund (VDF) subcommittee is being formed in each village and a sum of amount (Rs. 1,25,000/- to ST village and Rs. 2,50,000/- to PVTG village) is being provided through the project in the VDF bank account to help out the villagers in need and to increase this revolving fund in future. There is a guideline for use of this fund.

At present, as per the instruction only the JTELP GSPECs are receiving the VDF fund because JTDP GSPECs have already received the VDF fund during the JTDP period.

At present, all total 1733 JTELP GSPECs have been formed. In which 1464 GSPECs have been received Village Development Fund. VDF Fund has not been released in 25 villages because they are part of JTDP GSPEC. Secondly in additional there are four villages in SK DPMU having ST population very less and against the goal and objective of JTELP. As per discussion and instruction from team members not much of the activities (apart from agriculture) have been done in these villages. Rests of the villages are from Khunti DPMU and due to left wing extremism Gram Sabha meeting was not regular. The team tried to convince the members and it was at most done when this COVID 19 pandemic started and things were not in normal. Now the dialogue has already been initiated and the same will be released soon.

At present 1039 GSPECs are utilizing VDF in all the JTELP Districts. Key initiatives undertaken were as follows:

- Aggregation & sale of Paddy
- Fertilizer trading, Production/selling of organic fertilizer
- Lac Purchasing/selling business
- Aggregation & sale of NTFP
- Procurement of paddy thresher/Huller Machine
- Poultry Farming
- Paddy and vegetable cultivation
- Pig rearing, Fishery & Goat Rearing.

4. District wise details of SHG

Since the initial starting of the project, JTDS has been supporting these communities to develop skills that can up bring the women of the society to handle their saving, expenses and institutional strengthening during their ups and down. In this the women of the community came forward with the support from JTELP and constituted SHG. The SHG in their initial formation were trained to handle their books of accounts, loan and repayment methods and saving to a common account.

All the SHGs have the provision of getting seed capital under JTELP. Each SHG was to provide with a total of Rs. 10,000 (ST & Others SHGs) and Rs. 20,000 (PVTGs SHGs) in order to promote inter loaning and for the small business activity for women in group as well as individual.

A total 5265 SHGs have been formed by JTDS under the project having 61998 members (100% female). These have been formed on saturation based approach and there is no further scope of formation of SHG in the project area. Out of 5265 SHGs there are 467 PVTG SHGs, 4529 ST SHGs and 369 others (SC & OBC) SHGs. And all the SHGs have received Seed Capital @ 20,000 (PVTG SHGs) and 10,000 (ST & Others SHGs).

As per the mandate, 5265 SHGs have been handed over to NRLM fold.

AS per the above data all the SHGs have received the Seed Capital. Out of which all the SHGs are utilizing the seed Capital as inter-loaning. In addition to this, 800 SHGs are also involved in different types of economic activities to have additional incomes to the households.

Key initiatives/ enterprises under taken from Seed Capital are as follows:

- 4465 SHGs are utilizing seed capital for Inter-loaning purpose (to meet regular need for purchasing seed, fertilizer for Agriculture and allied activities, to meet medical need and supporting children in education, repairing of house and also for purchasing livestock to support in generating livelihood.)
- Members of 38 SHGs are involved in Tent House Business.
- Grocery shops, cloth shops and other business establishments are being run by 36 SHGs.

- 269 SHG are engaged in Livestock rearing (Goat, Poultry, Pig & Duck)
- 64 SHGs are involved in trading of Seasonal NTFP Produce.
- 117 SHGs are doing Collective farming (Vegetable, Mushroom)
- 21 SHGs are engaged in Tailoring
- 104 SHGs have procured, Power tiller, Huller, Motor Pump, Paddy Threasure & Centering Materials for rent out purposes.
- 39 SHGs involve in Bamboo craft (Tokari, Roap, Coat & Pattal Plate).
- 16 SHGs are involved in Puffed rice making, Haldi Powder making, Organic Manure making, Ayurvadic medicine making business.
- 46 SHGs in Crop aggregation &trading.
- 29 SHGs Running hotel in the weekly Hatt/market
- 2 SHGs are engaged in Food Supply to Anganwadi Centre.
- 10 SHGs have started Fish Farming taking panchayat pond on lease.

5. District wise details of Youth Groups

Youths are considered to be future of any community and proper channelization of youth every is important for society of grow and prosper. The objective of formation, nurturing and handholding of youth groups in the project is to make them aware of the environment and support them with a platform where they can grow with mutual help. This platform is also supposed to be used for discussion of different socioeconomic-cultural issues pertaining to society in general and to youth in particular.

Provisions of Seed capital for youth groups were made in the project to support and enhance their inner ability to do something for them and society in general. As per the Project Guideline the eligible youth groups have been provided seed capital of Rs. 40,000 in 2 installments. Also some of these youth groups have also received additional Rs.25000 from state government chief minister's fund.
