### **Assignment Title: Request for Proposal for Implementation of Oyster Mushroom Production under SCA to TSS Scheme**

Jharkhand Tribal Development Society (JTDS) has received financing from the Govt. of Jharkhand under SCA to TSS Scheme towards implementing Oyster Mushroom Cultivation in 6 TSP Districts of Jharkhand State. JTDS intends to apply the funds to eligible payments for implementation services for the above-mentioned activity. Jharkhand Tribal Development Society has a State Project Management Unit (SPMU) at Ranchi and 14 District Project Management Units in 14 TSP districts.

The consulting services (“the Services”) include carrying out the implementation of Mushroom Cultivation for ST Beneficiaries which includes providing training and hand holding support to the beneficiaries and support in establishing IGA in terms of both backward and forward linkages.

The State Project Management Unit of JTDS now invites eligible Agencies to submit the RFP in providing the above-mentioned services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The eligibility criteria for Agencies/NGOs are:

1. Should be legally registered and provide a self-attested copy of registration, PAN number and self-attested copy of PAN card.
2. The Agencies/NGOs, its Board of Directors and Key Management team members is not blacklisted for any prohibitive practices (such as fraud, corruption, collusion and coercive, obstructive practices). The Agency/NGO will have to submit a notarized affidavit from Authorized Signatory of NGO to this effect.
3. Should have implemented, over the last 5 years, at least 3 Rural/Tribal development Programs focused on oyster mushroom production in Jharkhand funded by GoJ/GoI/ NABARD or any other donors with minimum 2000 beneficiaries. (Provide copy of the letters of engagement/contracts/MOUs for the same).
4. Should have implemented Oyster mushroom production projects funded by GOJ in last two years.
5. Firms/agencies should be ISO certified.
6. The average annual turnover of the bidder Should not be less than Rs 50 lakh a year for the last three years as reflected in the last 3 years’ audited Balance Sheet and Financial Reports submitted to the concerned regulatory authorities (Funding which are not reflected in the Financial Statements, value of fixed assets in the Financial Statements will not be considered for the minimum average funding).

7. The Chief functionary of the institution should not be a formal member of any political party and furnish an undertaking to this effect.
8. Should provide details of any ongoing legal proceedings in the form of a declaration against the Agency/NGO, its Board of Directors and Key Management Team members.

To ensure proper implementation of the “Mushroom Cultivation” Program in Kolhan, South Chotanagpur, Santhal & Palamu Region JTDS will engage one experience agencies/FNGOs

The RFP received from interested Agencies/NGOs up to the submission date and time will be evaluated as per the procedures mentioned in this RFP.

## Terms of Reference

### Funded by the Government of Jharkhand

#### 1. Background

Removing rural poverty, estimated at 41.8% is the key challenge before India. Poverty is highest among the Scheduled Tribes (STs) in the Central and East Indian plateau encompassing Jharkhand. Among the STs, PVTGs are the most vulnerable and required hand holding support to come out of the abject poverty. Therefore, under the “Income Generating Activity” both identification of proper trade as well as training and capital support has been proposed.

#### 2. Objective:

The Agency/NGOs are required to undertake the following activities:

- ✓ The Agency/ NGO will be responsible for Analysing village level SECC 2011 data followed by participatory rural appraisal (PRA) process including social mapping and wealth ranking, followed by individual household survey and final verification for beneficiaries’ selection
- ✓ The Agency/NGO will be responsible for Enterprise Opportunity & Identification for Enterprise Development, confidence building training and assisting beneficiaries to select enterprise/income generating activities (IGA) for sustained livelihood
- ✓ The Agency/NGO will be responsible for Transfer of the relevant productive asset to beneficiaries.
- ✓ The Agency/NGO will be responsible for Technical skills training to beneficiary for income generation activities through mushroom cultivation.
- ✓ The Agency/NGO will be responsible for Weekly handholding support to understand and create awareness about accessing social welfare entitlements, financial inclusion, livelihoods and income generation) and follow up on regular basis to track beneficiary development
- ✓ The intervention is proposed for two zones:

All reports will have to be submitted to the DPMU based on the format provided by JTDS. The FNGO’s reporting obligations are as follows:

- An Inception Report within one month of the start of the assignment covering activities undertaken to date and a Tentative Month-wise Plan of Action for the assignment.
- Regular Monthly/Quarterly Reports through the period of the Agreement and these reports will be submitted within 15 days from the end of the reporting month/quarter. The Quarterly Report will have to also contain action plan for the following month/quarter.
- Closure Reports at the end of assignment showing progress, issues addressed, emerging issues to be addressed in the next plan, problems/constraints encountered and problems/constraints still to be resolved. It will also report on any innovative methods used to do work or work done differently; and also qualitative and quantitative reporting of short-term impacts of the project interventions on the community in their respective clusters.

## मशरूम उत्पादन

### भूमिका

झारखण्ड जैसे राज्य में मशरूम उत्पादन की अत्यंत सम्भावनाएं हैं क्योंकि यहाँ हर प्रकार के जमीन में सालो भर खेती नहीं हो पाती है।

ऐसी परिस्थिति में मशरूम उत्पादन लाभुकों के आजीविका के लिए एक सही विकल्प है। मशरूम का सब्जी के रूम में बहुत पुराने जमाने से प्रयोग किया जाता है, जबकि इसकी पौष्टिकता का ज्ञान नहीं था। मशरूम न केवल स्वास्थ्यवर्धक है बल्कि स्वादिष्ट एवं पौष्टिक होता है।

मशरूम पौष्टिक तत्वों से भरपूर होने के कारण शाकाहारियों के लिए बहुत लाभप्रद है। मशरूम उत्पादन प्रत्यक्ष अथवा अप्रत्यक्ष रूप में रोजगार उपलब्ध कराती है। मशरूम मधुमेह, रक्तचाप एवं मोटापे से ग्रस्त मनुष्यों के लिए लाभप्रद एवं शुद्ध शाकाहारी आहार है।

### योजना:—

झारखण्ड के जनजातीय समुदाय में मशरूम एक प्रसिद्ध खाद्य पदार्थ तथा इसकी अधिक माँग के आधार पर यह योजना क्रियान्वयन किया जाना है। इसके तहत कुल 30 क्लस्टर बनाया जाएगा जिसमें 01 क्लस्टर में 50 महिला लाभुक होंगे, इस तरह से कुल 1500 जनजातीय महिलाओं को लाभ प्राप्त होगा। मशरूम की खेती से हरेक महिला कम-से-कम खेती कर सकते हैं।

### जे0टी0डी0एस0 की ज़मता:—

जे0टी0डी0एस0 द्वारा पूर्व से 2 जिलों यथा खूँटी, एवं गुमला में 500 परिवार के साथ मशरूम उत्पादन का कार्य किया जा रहा है जिसमें लाभुकों को प्रशिक्षण, तकनीकी सहयोग, मशरूम उत्पादन हेतु पोलिथीन बैग, मशरूम बीज एवं अन्य सामग्री उपलब्ध करायी जा रही है इसमें महिलाओं की भागीदारी सराहनीय है।

दिशा निर्देश :-

इस कार्य के क्रियान्वयन हेतु मशरूम उत्पादन हेतु पूर्व से प्राप्त अनुभव के आधार पर गैर सरकारी संस्था के माध्यम से किया जाना है जिसका चयन जे0टी0डी0एस0 द्वारा किया जाएगा।

लाभुकों का चयन सर्वसम्मति से ग्राम सभा द्वारा किया जाना है। लाभुक चयन के समय ऐसे लाभुक (जनजातीय महिलायें) का चयन किया जाएगा जो अति पिछड़े हो तथा उनके पास खेती योग्य बहुत ही कम जमीन उपलब्ध हो। लाभुक चयन करते समय यह भी ध्यान रखा जाएगा की अधिक से अधिक महिला लाभुक का चयन हो।

लाभुकों के चयन के उपरांत लाभुकों की सूची जिला के माध्यम से जे0टी0डी0एस0 राज्य कार्यालय को अनुमोदन हेतु उपलब्ध कराया जायेगा।

अनुमोदन उपरांत चयनीत संस्था द्वारा ग्राम सभा कार्यक्रम क्रियान्वय समिति (GSPEC) के सहयोग से कार्यो का क्रियान्वयन किया जाएगा।

अनुश्रवण:-

जमीनी स्तर पर कार्य प्रगति का अनुश्रवण जे0टी0डी0एस0 के जिला इकाई द्वारा किया जाएगा तथा इसका प्रतिवेदन राज्य कार्यालय को उपलब्ध कराई जाएगी। राज्य कार्यालय द्वारा उक्त गतिविधि का कार्य प्रगति प्रतिवेदन प्रत्येक माह के अंत में आदिवासी कल्याण आयुक्त, झारखण्ड सरकार को समर्पित की जाएगी।

गतिविधि से लाभ:-

जनजातीय महिलाओं की घर में आसानी से रोजगार करने का साधन प्राप्त होगा कम लागत एवं कम समय में अच्छी आमदनी होगी जिससे घर परिवार का जीवन स्तर में वृद्धि होगी। साथ ही जनजातीय समुदाय के भोजन में प्रोटीन की मात्रा की भी वृद्धि हो सकती है। इस योजना से चयनित परिवार को लगभग रू.20000/- सालाना आय वृद्धि हो सकती है।
