REQUEST FOR QUOTATIONS

Support for Livestock Distribution (Ducklings) and other related items to PVTGs under CCD Scheme

1. The *Jharkhand Tribal Development Society (JTDS)* has received financing from the Govt of Jharkhand under CCD (Conservative cum Community Development) Scheme, and intends to apply part of this financing to the purchase for which this request for quotations (RFQ) is issued.

2. The bidder shall not have any actual, potential or reasonably perceived conflict of interest. A bidder with an actual, potential or reasonably perceived conflict of interest shall be disqualified. A bidder, including their respective personnel and affiliates, are considered to have a conflict of interest if any of them has a relationship that provides them with undue or undisclosed information about or influence over the evaluation process and the execution of the contract, b) participates in more than one quotation under this procurement action, c) has a business or family relationship with a member of the purchaser's board of directors or its personnel.

A bidder and the supplier have an ongoing obligation to promptly disclose any situation of actual, potential or reasonably perceived conflict of interest during the preparation of the quotation, the evaluation process or the contract execution. Failure to properly disclose any of said situations in a promptly manner may lead to appropriate actions, including the disqualification of the bidder, the termination of the contract and any other as appropriate.

Bidders and any of their personnel and agents, and their sub-consultants, sub-contractors, service providers, suppliers, sub-suppliers, and the latter's personnel and agents are required to fully cooperate with any investigation conducted by JTDS, including by making personnel available for interviews and by providing full access to any and all accounts, premises, documents and records (including electronic records) relating to this bidding process or the execution of the contract and to have such accounts, premises, records and documents audited and/or inspected by auditors and/or investigators appointed by JTDS.

a. Bidders have the ongoing obligation to disclose in their quotation and later in writing as may become relevant: (i) any administrative sanctions, criminal convictions or temporary suspensions of themselves or any of their key personnel or agents for corrupt, fraudulent, collusive, coercive or obstructive practices, and (ii) any commissions or fees paid or to be paid to agents or other parties in connection with this bidding process or the execution of the contract. Bidders must disclose the name and contact details of the agent or other party and the reason, amount and currency of the commission or fee paid or to be paid. Failure to comply with these disclosure obligations may lead to rejection of the quotation or termination of the contract.

b. Bidders shall keep all records and documents, including electronic records, relating to this bidding process available for a minimum of three (3) years after notification of completion of the process or, in case the bidder is awarded the Contract, execution of the contract.

3. Jharkhand Tribal Development Society (JTDS) invites you to submit your sealed price quotation in a pro forma invoice format for the supply of the items listed (Attached) of this RFQ.

5. The quotation should be accompanied by:

- a. Copy of your business registration
- b. Copy of PAN and GST Registration Certificate
- c. Complete price and delivery schedule;
- d. Last three years Audit Report & Certification of Turnover of at least 50 lakh or more in supply of Livestock and other related items etc
- e. Experience of working with various Deptt. under Government of Jharkhand regarding supply of livestock distribution (Piggery) and other items in last 3 years (at least three bulk orders of INR 50 lakhs or more for similar kind of supply. (Work Order must be attached).
- f. Empanelled and experienced Vendors/Agency/Organization by Directorate of Animal Husbandry (GoJ) under *Mukhya Mantri Pashudhan Yojna* vide letter no.1558/T dated 03.11.2023 will be given preference/weightage. (Empanelment list must be attached).
- g. JTDS can divide/allot the work to one or more Vendors/Agency/Organization as per its discretion if quoted rate is same or JTDS can allot the work after negotiation.
- h. Quotation of all materials (Livestock/other related items etc) must be submitted in prescribed format attached in **Annexure-1**.

6. The deadline for receipt of your quotation is 9, 01, 2024. 15: 00 Hrs

7. Quotations should be submitted in physical form/registered post, by the deadline and to the address stated above.
8. Bidders must quote all items in the RFQ. A partial quote will not be accepted. If a quotation shows items listed but not priced, their prices shall be assumed to be included in the prices of other items. An item not listed in the quotation shall be assumed not to be included in the quotation.
9. **Evaluation.** The purchaser shall award the contract to the bidder whose offer has been determined to be the lowest priced quotation and is substantially responsive to the request for quotation, provided further that the bidder is determined to be qualified to perform the contract satisfactorily.

The purchaser's evaluation of a quotation may take into account, in addition to meeting the minimum technical and qualification requirements, the following factors;

- (a) **Delivery schedule.** The items are required to be delivered within the time as specified in the delivery schedule. Quotations offering delivery beyond this period in delivery time shall be treated as non-responsive.


10. **Prices and Delivery:** Prices shall be in INR and to be quoted for delivery at Block Hqs./Villages of all 04 districts (Dumka, Pakur, Godda and Sahebganj) of JTDS project Area (TSP Districts). The Destination price should include all freight, insurance and transport costs.

11. **Payment.** Payment will be made in full within 30 days after delivery and acceptance of goods.

12. **Delivery Schedule:** All items should be delivered *within 30 days* after signature of contract/purchase order. Bidders must state an exact delivery time in the quotation.

13. **Warranty:** Items offered should be covered by replacement of ducklings if mortality occurs within 07days from the date of delivery to the purchaser/procuring entity. Goods offered shall be as per specification mentioned in RFQ.
14. **Origin:** India
15. **Validity.** Your quotation should be valid for a period of 60 days from the date of your quotation.
